Court Case Settled

On June 15, 2012, a status hearing took place for the **Temporary Restraining Order and Preliminary Injuction** filed by Beverly Fields and Yurell Washington in District of Columbia Superior Court against Black Ski, Inc. on April 19, 2012 regarding absentee balloting and adherence to our bylaws relating to our 2012 election. The following settlement was agreed to by President Reginald Johnson, Board of Director's Chairman Russell Bacon after negotiations facilitated by Black Ski's Lawyer:

Order of Dismissal Entered on Docket 6/18/12. Signed in Chambers by Judge Macaluso on 6/18/12. E-filed and served via US Mail on 6/18/12. It is [SO ORDERED THAT]: This case is dismissed with prejudice under the following conditions:

(1) the ongoing election process will continue until its conclusion; (2) Black Ski, Inc. ("BSI") will not remove Plaintiffs Beverly Ann Fields or Yurell Washington from their positions with BSI or membership in BSI or take any action against Plaintiffs in retaliation for their filing of this lawsuit. PAYMENTS

The payment schedule outlined on trip flyer must be adhered to unless arrangements are made with the Trip Directors. Failure to receive payment by date specified may cause loss of reservation (see cancellation for non-payment below). Monies received within thirty (30) days of the trip date will only be accepted in the form of a money order, certified check or cashier's check. No cash or personal check transactions will be accepted.

CANCELLATION

(a) Request for cancellation: A request to cancel from a trip must be in writing and directed to the Trip Director. The participant by voluntarily requesting to be canceled from the trip will be assessed the non-refundable deposit fee (as specified on trip flyer) plus any payments that have been made to vendors on his/her behalf.
